Highlights of PAPERS Forum

A very successful second annual PAPERS Forum was held at the Harrisburg Hilton Hotel, April 18-20, with 202 persons interested in Pennsylvania's public retirement systems attending. The agenda included a plethora of educational pension related topics.

A panel discussion on *Critical Pension Issues* included trustees from the Municipal Employees Retirement System

(MERS), State Employees Retirement System (SERS) and the Public School Employees Retirement System (PSERS). Next, a session on *Corporate Governance* led by Peter Gilbert, Chief Investment Officer (CIO) at the Pennsylvania State Employees Retirement System, highlighted many simple and inexpensive ways for fiduciaries to exercise their corporate governance responsibilities. In addition to being CIO at SERS, Peter is a member of the Executive Committee of the Council of Institutional Investors. A roundtable on *Fiduciary Responsibility* included participants (*left to right in photo above*) W. William Butler, pension consultant; Diane R. Marburger, Butler County Treasurer and Jeffrey B. Clay, PSERS Executive Director.

The first day afternoon sessions focused on investment related topics with two parallel tracts offered - one for beginners and a second for more advance practitioners. Alan VanNoord, CIO at PSERS, led a very interesting discussion on **Seeking Alpha in a Low Return Environment**. A session entitled **Auditing** featured Don Halke from PSERS on internal auditing and Tom Swider, Director of Municipal Pension Audits from the Auditor General's Office, on fiscal audits. Jim Allen, Executive Director at MERS, led a workshop **Actuarial Science 101** and Greg Stump from EFI Actuaries did an informative slide presentation **Understanding Your Actuary**.

The conference concluded Thursday with a business meeting and a presentation by the PAPERS board members on the *Purpose and Mission of PAPERS*. Thursday afternoon was a closing time of rest and relaxation with options for a tour of the PSERS facilities or a round of golf at Dauphin Highlands Golf Course.
