



2019 PAPERS MEMBERSHIP and SPONSOR FEES

A current PAPERS membership is required for attendance at conferences and for participation in the Public Pension Professional certification program. Any number of representatives from an organization which qualifies for the group-based Participating, Associate or Affiliate categories of membership may attend PAPERS annual conferences, subject to the specific registration fees for each event. Sustaining Membership is individually based as noted below.

PARTICIPATING MEMBERSHIP - Public pension plans in the Commonwealth of Pennsylvania

Annual dues for public pension plans are:

Early bird rate (*paid on or before 3/31/2019*) - \$125; **Standard rate** (*paid after 3/31/2019*) - \$150

- Member systems receive one complimentary registration to the spring Forum and the Fall Workshop
- The registration fee for each additional pension plan representative attending PAPERS' conferences - Forum: early bird - \$125; standard - \$150; Fall Workshop: early bird - \$100; standard - \$125

ASSOCIATE MEMBERSHIP - Annual corporate dues are \$1,000

Asset managers and firms providing investment management and/or legal services to public pension funds

- Forum registration fee for each Associate Member representative: early bird - \$750; standard - \$825
- Fall Workshop registration fee for each Associate Member representative: early bird - \$400; standard - \$475

AFFILIATE MEMBERSHIP - Annual corporate dues are \$500

Firms, organizations, unions and consultants providing services to public pension plans, exclusive of investment management and legal services

- Forum registration fee for each Affiliate Member representative: early bird - \$375; standard - \$425.
- Fall Workshop registration fee for each Affiliate Member representatives: early bird - \$200, standard - \$250

SUSTAINING MEMBERSHIP - Annual dues for eligible individuals are \$75

Individual membership available only to those persons with an interest in public pensions but not affiliated with an organization which qualifies for group membership in any other category.

- Fall Workshop registration fee for each Sustaining Member: early bird - \$50; standard - \$75
