## Affiliate Membership – Annual dues \$750

**Available to:** Any public or private corporation, partnership, organization (including non-profits, unions & consultants) or individual that regularly provides services, exclusive of investment management and legal work, to public pension plans

## Associate Membership – Annual dues \$1,500

**Available to:** Any public or private corporation, partnership, organization, or individual that regularly provides investment management and/or legal services to public pension plans.

## Sustaining Membership – Annual dues \$75

**Available to:** Individual membership open only to those persons with an interest in public pensions but not affiliated with an organization which qualifies for group membership in any other category above
